### 22/04/2020 – Clarifications to the information to be sent to investors in funds referring to a benchmark index in the KIID

We would like to inform you that as from 22/04/2020, the Key Investor Information Documents (KIID) of the funds listed below managed by CPR Asset Management will be amended to include the following regulatory change:

#### - **Update of wording relating to benchmark indexes in the KIID**

On 29 March 2019, the ESMA published an update to its Q&As document relating to application of the UCITS Directive.

This update primarily concerns the information to be communicated in the KIID of UCITS and in particular, the use of benchmark indexes.

The ESMA has therefore clarified the obligation for managers of UCITS to declare whether they apply "active" or "passive" management, according to the definitions given by the ESMA and, when management of the UCITS is "active", to indicate the degree of freedom in relation to its benchmark.
